Annual sealed Tender are invited from intending participants for transportation of WHEAT/Bardana and Misc:work etc within district/other District, within region and other regions for the period ending 28th Feb:2011 (Year 2010 -2011) by (Registered Post/Courier Service only) in the prescribed form obtainable from this office at Rs: 2,000/- (Rupees Two Thousand only) per form (non refundable) upto **19-03-2010**, so as to reach upto **20-03-2010 at 02.00 P.M.** in the Office of the Deputy Director Food, Hyderabad Region, Room NO: 109 Block A, Ground Floor Shahbaz Building Hyderabad Region, which will be opened on the same day i.e. **20-03-2010, at 2.30 P.M.** in presence of the parties or their representative, who wish to be present.

No tender form shall be issued on the day of opening of the tenders.

For tendering the rates, following terms and condition may also be fulfilled.

1. The parties should fill in tender form for each District/PRCs separately.
2. The Parties will have to furnish a personal Surety Bond on Judicial/Stamp Paper of Rs.500/- for Other Region Rs. 20.000 Million, other district (within region) including the Bolhari/Kotri Rs:10.00 Million and within district Rs:5.00 Million with concerned District Food Controller of this Region. In case of contract will be awarded.
3. Each tender should be accompanied by Security Deposit/ Earnest Money in the form of CDR pledged to the Deputy Director Food, Hyderabad Region.
4. The rates should be quoted in the words as well as in figures. Incomplete and conditional offers shall be liable to rejection.
5. The Tender received after due date and time will not be entertained.
6. The other terms and conditions are available and the details of work and the amount of security deposit are shown in the statement attached to the Tender Form are available in the Regional Office, Hyderabad.
7. The envelope should invariably bear the words "TENDERS".
8. The Bidder who wish to under take the work also have to attach with the application an statement of his Bank account for last two years /Financial Stability Certificate obtainable from concern schedule Bank and Income Tax Certificate issued by Income Tax Department.
9. That the transporter shall have sufficient experience of the work.
10. That he will not be having any criminal cases against him and involved in any defalcation cases.
11. That if the transporter is a firm a Registration Certificate with the concerned Government Department shall also be provided, with details of the names of the partners and their postal addresses (Permanent as well as present).
12. That a list of the trucks if owned by the transporter shall be furnished with photocopy of documents showing ownership of Trucks.
13. That correct official residential address, alongwith telephone No: attested photocopy of Identity Card shall be provided.
14. That certificate from the Administrative Officer of the area shall be furnished to the effect that the applicant is neither a Government servant nor a student and nor a convict.
15. Three Specimen signatures in triplicate dully attested.
16. The contractor shall be fully responsible for all enroute shortages or damages etc and will be required to make good the loss by the replenishment or shall have to pay its cost. The recovery of cost of wheat shall be affected at Rs: 2 per Kg over and above, the Government issue rate prevailing at that time. If, any change in the rate is found, the recovery will be made at that rate. This cost shall be recovered from the running bills pending bills. Security Deposit or as arrears of land Revenue and thereafter no claim will be entertained.
