Qualification Assessment of the participating firms will be opened on the same day at 12:00 Noon by the Tender Opening Committee in presence of participating contractors / authorized representatives of the firms who wish to be present. In case of tenders un-responded the same will be issued on 05.01.2012 at 11:00 A.M and received back on 06.01.2012 upto 11.00 A.M & opened on same day at 12:00 Noon, and issued on 07.01.2012 at 11:00 A.M and received back on 09.01.2012 upto 11:00 A.M & opened on same day at 12.00 Noon.

The Qualification Assessment so opened shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened and publicly announced on the date and time that will be communicated in writing to all the qualified contractors / firms in advance. Financial bid / proposal of technically un-qualified contractors shall be returned to them un-opened.
