

3. On schedule date of Bid opening i-e 26-07-2010 only the envelop of "Technical Proposal".will be opened and envelop marked "Commercial Proposal" will be retained in the safe custody as per SPPRA RULES 2010.
4. After Technical Evaluation, envelope of "Commercial Proposal" of technically accepted bidders will be opened with prior intimation to successful bidder(s). The commercial proposal of bids found technically non-conforming will be returned Unopened to the respective bidder as per SPPRA RULES 2010.
5. Tender shall be received back on 26-07-2010, Up to 1.00 PM.
6. Tender shall be opened on 26-07-2010, at 2.00 PM in presence of tenders or their authorized representative who wish to attend in presence of District purchase committee.
7. Eligibility Conditions as per SPPRA RULES 2010, for tender participants are as under,
 - i) Documentary evidence of work of supplies in progress and certificate of satisfactory completion.
 - ii) Registration with income tax Department (NTN) Certificate.
 - iii) Registration with Sales tax Department (GST) Certificate.

- iv) Undertaking on Affidavit that firm is not involved in any litigation or abandoned any work in any department.
8. The bidders should submit earnest money @ 2% in shape of call deposit / pay orders / Demand Draft prepared from the scheduled bank in favor of undersigned.
 9. Affidavit with effect that all documents / particulars / information furnished is true and correct.
 10. The undersigned reserves the right to enhance / reduce the quantity without assigning any reason.
 11. The procuring agency shall announce the result of bid evaluation in the form of a report, giving justification for acceptance or rejection of bids at least 10 days prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA RULES.
