4. In case of Firm list of Partners / Partnership deed giving full particulars of Director / Proprietor or other concerned along with Power of attorney . In case of sole proprietor such undertaking on affidavit be furnished.
5. The intending contractor should furnish Bank Statement of last three years to ascertain the financial status of the same along with list of works already carried out or in progress in various government organizations along with certificate of satisfactory work done.
6. Affidavit with the effect that all the documents / information furnish by the participants are true and correct.
