NOTICE INVITING TENDERS

Bidding is open to all bidders from eligible source as defined in part one (FIXED) of bidding documents for national competitive Bidding: Procurement of Works – Small contractors containing the condition.

Bids shall be valid for a period of 35 days after bid opening and must be accompanied by bid security 3% of the quoted rates in shape of call deposit in the name of District Officer Education Works (W&S) Khairpur from any schedule Bank of Pakistan at the time of receiving and opening of tenders on the dates mentioned as under near comprehensive high school Khairpur @ 1:00 pm in the presence of Tender Opening / Evaluation Committee Khairpur comprising District Coordination Officer Khairpur. Executive District Officer Finance Department Khairpur. Executive District Officer (Works & Services) Department Khairpur. District Officer Education Works Khairpur & Divisional Account Officer of this office & the bidders or their authorized representatives who wish to be present.
5. All Bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post – qualification whether the bidder is qualified to perform the work.
6. Bids are required to be submitted on item rate basis (not on the basis of composite schedule rates with percentage premium) and the rates and amount (In Rupees) must be filled by the bidders for each item in the Bill of Quantities and provide a total price. Non – Compliance may result in rejection of bid.
7. In case of dispute, dispute resolution mechanism will be as per SPPRA rules 2010.
8. As provided in the bidding documents, bidders engaged in fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
9. Tender will be issued to bidders who possess ten years experience in the building works such certificate of Works & Services Department is required to be attached with the application of bidders.
10. Application demanding for tenders must be supported with the complete profile of technical works executed previously and financial documents for security.
11. The competent Authority reserves the right to reject any or all tenders subjected to relevant provisions of SPPRA Rule 2010.
12. For any other requirements please refer bid documents.
13. If any of the information furnished by the contractor / firm proves to be false at any stage, the contract, even if awarded is liable for cancellation and other action. Legal and other wise. Will be taken against contractor/firm.
