- c) Registration Deeds. Partnership Deeds and Power of Attorney in case of firms.
- d) Details of present enlistment with Government / Semi Government including categories with copies of registration.
- e) Details of similar works executed by the contractors in the past 10 years indicating scope of works estimated cost and time taken for completion duly certified by the concerned officials.
- f) List and location of equipments transport and machinery available with the contractor for this job.
- g) Affidavit that the contractor has neither been blacklisted by any agency nor involved in any subversive activities.
- h) Copy of fresh enlistment letter of Pakistan Engineering Council.
- i) Bio-Data of the technical staff permanently employed and available with the firm / contractor for the project.
- j) Income Tax Registration & Clearance Certificate for the post three years and CNIC number of the contractor.
- k) Financial stability **certificate** issued by the scheduled Banks of good repute.

- 1) Present workload and commitments as against the financial position of company / firm to be furnished with documentary evidence.
- 1) List of cases entered into arbitration / litigation. It not invited then affidavit to the effect that the firm / contractor was not involved in any litigation and no work was rescinded, if any.
- m) Any additional information that applicant may like to furnish in support of its paper.
- o) The Competent Authority reserves the right to accept or reject any or all tenders / bid proposals, subject to the relevant procedure of SPPRA Rules.
- p) The bidding will be two stage-two envelope procedure. Only the firms whose technical proposal is acceptable will be further invited for financial proposal.
