3- Eligibility / Conditions:-

- i) Registration with Pakistan Engineering Council in the relevant category or above.
- ii) For Electrical work valid license issued from Inspectorate of Electrical License Sindh of the similar region with respect to works, for (Serial No.3 & 4).
- iii) Name of the Firm/Contractor/Company Address and Telephone No. Fax No. Name of the key personnel.
- iv) Detail eligibility criteria / conditions are attached / available with the bidding documents.
- v) Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
- vi) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- vii) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- viii) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- ix) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- x) The bidder should be well versed with the site conditions and should have completed at least 2 Nos. works under similar conditions (List to be provided with bid).
- xi) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- xii) Affidavits to the effect that all documents / particulars / information furnished are true and correct.
- xiii) Conditional Tenders will not be entertained.
- xiv) Advertisement can be seen on Sindh Government web site (www.Sindh.gov.pk) and SPPRA web site.
- xv) Undertaking on stamp paper that firm is not involved in any kind of litigation, departmental rift, abandoned or unnecessary delay in completion of any work in the Government and as well as in private organizations.
