TENDER NOTICE.

Sealed tenders on prescribed Tender forms are invited from intending participants for transportation of wheat from various PRCs to PRCs / Mills PRCs and labour works of Mirpurkhas & Sanghar Districts (within District) for the period ending 28-02-2012 (Crop 2010-11, Year 2011-12) through (Register post / Courier services only) obtainable from this office @ Rs. 2000/- (Two Thousand only) per form (Non refundable) from the date of first publication to 23-10-2011 so as to reach this Regional Directorate at Digri Road Mirpurkhas upto **24-10-2011** by **02:00 PM** which will be opened on the same day i.e. at 2:30 PM in presence of the Committee constituted for the purpose for opening of tender and the parties or their authorized representatives who wish to be present.

For tendering the rates the following terms and conditions must also be fulfilled.

1. The parties should quote separate rate per beg of 100 Kgs net / per Ton net in tender form for transportation of wheat for each route separately.
 2. The parties will have to furnish a personal Surety Bond on Judicial / Stamp Paper of Rs. 500/-, 5.00 Million with concerned District Food Controller, in case the contract is awarded in their favour.
 3. Each tender should be accompanied by security deposit of RS. 50000/- (for each route within district) in the form of CDR pledged in favour of Deputy Director Food, Mirpurkhas Region and for each work as shown in the statement of works, which will be supplied with tender form after production of tender fee.
 4. The rates should be quoted in words as well as in figures. Incomplete and conditional offers shall be liable to rejection.
 5. The Tender received after due date and time will not be entertained.
 6. The other terms and conditions are attached with the Tender Form.
 7. The envelope should invariably bear the word "TENDERS"
 8. The new Bidder who wish to undertake the work shall have to attach with the application an statement of his Bank account for last two years / Financial Stability Certificate obtained from any scheduled Bank and Income Tax Certificate issued by Income Tax Department with experience certificate of his work in the relevant field, if any.
- The bidder shall not be having any criminal case against him or involved in any defalcation case, for which he will have to produce an affidavit duly attested by Oath Commissioner in this connection.
10. The Bidders shall submit their bids in a single package containing two separate envelope. Each envelope shall contain separately the financial proposal and the technical proposal. The first envelope shall be marked as "TECHNICAL PROPOSAL" and second as "FINANCIAL PROPOSAL" in bold and legible letter to avoid confusion under the relevant provision of Rule 46 (2) of SPP Rules, 2010".
 11. That a list of the trucks if owned by the transporter shall also be furnished with photocopy of documents showing ownership of Trucks.
 12. That correct official, Residential Address, alongwith telephone Number and attested photocopy of Identity Card shall also be provided by the new bidder

14. The Deputy Director Food, Mirpurkhas Region may reject all or any bid or proposals at any time prior to the acceptance of a bid or proposal subject to the relevant provisions of SPPRA Rules.
15. The Contractor shall be solely responsible for the enroute shortages or damages etc and will be required to make the loss good by replenishment or shall have to pay the cost. The recovery of cost of such shortages shall be effected at Rs: 2/- per Kg over and above the government issue rate prevailing at that time including all charges or open market rate whichever is higher. This cost can be recovered from the running bills / pending bills / Security Deposits or as arrears of Land Revenue and no counter claim will be entertained at later stage.
