

## ANNUAL TENDER NOTICE.

Sealed annual tender on separate Tender form for each district are invited from intending participants for transportation of wheat from all WPC to PRC of Sanghar and Mirpurkhas district (within District) and from all WPCs / PRCs of Sanghar district to all PRC of Mirpurkhas and Tharparkar district (within Region) besides Transportation of bardana from all PRC's to WPCs within District (Mirpurkhas / Sanghar) and other godown works etc. Mirpurkhas / Sanghar / Tharparkar (within district) for the period ending 28-02-2011 (Year 2010-2011) through (Register post / Courier services only) in the prescribed Tender form obtained from this office @ Rs. 2000/- (Two Thousand only ) per tender form (Non refundable) upto 22-01-2010 so as to reach this Regional Directorate at Digri Road Mirpurkhas upto 23-01-2010 by 2:30 PM which will be opened on the same day i.e. at 3:00 PM in presence of the parties or their authorized representatives who wish to be present.

For tendering the rates the following terms and conditions must also be fulfilled.

1. The parties should quote separate rate per beg 100 Kgs net / per Ton / Per bale or bundle in tender form for transportation of wheat / bardana from each WPCs to PRC or from PRC to WPCs in case of bardana as the case may be.
2. The parties will have to furnish a personal Surety Bond on Judicial / Stamp Paper of Rs. 500/- for other District (Within Region) for Rs. 10.00 Million with concerned District Food Controller of this Region, in case the contract is awarded in his favour.
3. Each tender should be accompanied by Earnest Money in the form of CDR pledged in favour of Deputy Director Food, Mirpurkhas Region, for each work as shown in the statement of works, which will be supplied with every tender form.
4. The rates should be quoted in words as well as in figures. Incomplete and conditional offers shall be liable to rejection.
5. The Tender received after due date and time will not be entertained.
6. The other terms and conditions are attached with the Tender Form.
7. The envelope should invariably bear the word "TENDERS"
8. The new Bidder who wish to undertake the work shall have to attach with the application an statement of his Bank account for last two years / Financial Stability Certificate obtained from any scheduled Bank and Income Tax Certificate issued by Income Tax Department and the experience certificate of his work in the relevant field, if any.
9. The bidder shall not be having any criminal case against him or involved in any defalcation case, for which he will have to produce an affidavit duly attested by Oath Commissioner in this connection.
10. If the transporter is a firm, a Registration Certificate of the concerned Government Department shall also be provided, with details of the names of the partners and their postal addresses (Present as well as Permanent).
11. That a list of the trucks if owned by the transporter shall also be furnished with photocopy of documents showing ownership of Trucks.
12. That correct official, Residential Address, alongwith telephone Number and attested photocopy of Identity Card shall also be provided, by the new bidder.

13. That certificate from the Nazim of the area shall also be furnished to the effect that the applicant is neither a Government servant nor a student or a convict.
14. Three specimen signatures duly attested will also be submitted.
15. The Deputy Director Food, Mirpurkhas Region may reject all or any bid or proposals at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules.
16. The Contractor shall be solely responsible for the all enroute shortages or damages etc and will be required to make the loss good by replenishment or shall have to pay the cost. The recovery of cost of such shortages shall be effected at Rs: 2/- per Kg over and above the government issue rate prevailing at that time including all charges or open market rate whichever is higher. This cost can be recovered from the running bills / pending bills / Security Deposits or as arrears of Land Revenue and no counter claim will be entertained at later stage.
