The application for purchase of tender document should accompany the 2% Earnest money of the estimated cost as mentioned in the list in the shape of Pay Order or Deposit-At-Call from any scheduled bank of Pakistan duly pledged to the Deputy Director (Planning, Development, Monitoring & Implementation Cell). For the electric work, electric license from Inspector Electric is required. Blank tender documents will be issued to the applicant on next working day after scrutiny of the application and on payment of cost of tender form (non-refundable).

The tender documents will be issued from the date of publication in the press and up to 10th October, 2011, and can be obtained from the office of under signed during office hours. The tenders duly filled in will be received back from the intending bidders on 12th October, 2011, till 12:00 pm. The tenders will be opened at 12:05 pm on same date, i.e., 12th October, 2011, in the presence of participating contractors or there authorized representatives, in the supervision of Tender Committee as constituted by the competent authority, in the office of the undersigned.

The estimate, drawing, design and specifications can be seen on any working day during office hours. The conditional tenders will not be accepted and the undersigned reserves the right in his sole discretion to reject any or all the applications by informing the reasons thereof and no claim whatsoever shall be entertained on this account. The successful contractor, whose tender is accepted, will have to obtain adhesive stamps from Assistant Superintendent Stamps, Government of Sindh, Karachi, on payment of stamp fees according to schedule prescribed as per the latest notification of competent authority and sign the agreement.

The eligibility conditions for participating in the tender are:

- i) Registration with Pakistan Engineering Council in the relevant field of specialization of work and to the extent of tender amount of each work.
- ii) Bio-data of Engineers and Technical staff working with the contractor's firm.

- iii) Documentary evidence of works executed or in progress and certificate satisfactory completion of works by the executing agency.
- iv) List of works in progress indicating cost of each work and copy of Letter of Award of each work.
- v) List of machinery and equipment available with documentary evidence of its ownership.
- vi) Bank certificate showing the credit of worthiness along with Bank Statement.

The intending bidders/firms are also required to provide:

- i) Copy of their NTN and CNIC.
- ii) Undertaking on affidavit that the firm is not involved in any litigation of abandoning any work and it has not been black-listed previously by any executing agency.
- iii) Affidavit to the effect that all documents/partnership-deed/particulars/information are true and correct.
