In accordance with Public Procurement Rule, 2010, the Police Department, Government of Sindh, invites tenders from Manufacturers Companies registered with Sales Tax and Income Tax Department for the supply of Medicine for Sindh Police :-

INSTRUCTIONS:

1. Interested companies may obtain the tender document for the supply of Medicine from the office of the AIGP (Logistics), Central Police Office, Sindh 2nd floor CPO Building I.I. Chundrigar Road, Karachi by submitting an application on their letter head alongwith tender fees (amounting to Rs.250/- non refundable) with effect from 26.04.2010 to 10.05.2010.
2. Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of estimated cost of Rs. 10 million in the form of Pay Order (Payee's A/c in favour of PPO Sindh) should be dropped in the tender box kept in office of AIGP/Logistics. CPO Sindh, 2nd floor CPO Building I.I.Chundrigar Road, Karachi on "11.05.2010" 1400 hours.
3. The tender shall be opened on 11.05.2010 at 14:30 in presence of Purchase Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room of Central Police Office, Sindh, Ground Floor, I.I.Chundrigar Road, Karachi.
4. Only Companies registered with Income Tax and Sales Tax department are eligible to participate in the tenders (Documentary proof required).
5. Only bids offered on the prescribed tender form issued by the Police department shall be accepted. However, additional sheets may be attached, if required.
6. Conditional tender / application will not be entertained.
7. Supply must be completed within 15 days and handed over on (F.O.R) destination Police Hospital Garden, Karachi. All payment shall be subject to clearance by Inspection Committee within 30 days of submission of supply note/bills.
8. The competent authority reserves the right to reject any or all tenders in accordance with Public Procurement Rules, 2010.
