The Committee shall deliberate and submit its recommendations within six (06) weeks on the following points as directed in para-15 of the above order of the High Court of Sindh.

The Committee shall conduct a study pertaining to the fact that whether the existing number of colleges in the Province is proportionate to existing population.

- In the province of Sindh, the degree colleges award BA/BSc Degree in two years. While the same degree is awarded in four years in other provinces. The Committee is mandated to evaluate this practice and recommend as to how to bring the existing degree time period at par with that prevailing nationally and globally.
- The Committee is mandated to recommend whether the relevant and necessary subjects are provided in the syllabus of the degree programs in the colleges.
