1. **Single stage one envelope procedure** will be adopted for the tender process. Each bid shall comprise one single envelope containing the financial proposal and required information mentioned in Evaluation Criteria of bidding documents should be uploaded on EPADS and original set of the same submitted in the office of the SSP/Principal PTC Shahdadpur.
2. Interested suppliers / firms may download the tender document for the supply of dietary food items for the trainees Mess of PTC Shahdadpur from Sindh Police website www.sindhpolice.gov.pk and SPPRA website <https://portalsindh.gov.pk> by submitting tender fee of **Rs.5000/-** (non- refundable) from the date of publication to **Tuesday 04th-August-2026 up-to 1400 hrs.**

Sealed Tender on prescribed Performa in Original along with **2% earnest money** of offered Bid and Tender Fees in the form of Pay Order in favour of Principal, PTC Shahdadpur, should be submitted at the office of the SSP / Principal, Police Training College Shahdadpur on **Tuesday 04th-August-2026 up-to 1400 hrs.**
4. The tender shall be open on **Tuesday 04th-August-2026 at 1430 hrs** in presence of Procurement Committee and representatives of bidders who choose to be present on the occasion in the office of the Principal PTC Shahdadpur.
5. Only suppliers firms registered with FBR income, Sales Tax & other related taxes are eligible to participate in the tender (Documentary proof required).
6. All items should be hygienic and best quality-wise and samples may also be provided.
7. Only bid offered on the prescribed tender form issued by the Police Department will be accepted. However, additional sheets may be attached, if required.
