NO.SOVI (SGA&CD)/10(1)/2024: In pursuance of the decision taken in the Provincial Cabinet Meeting held on 03.04.2024 and 2.5.2024 (continued on 4.5.2024) and Rule 37 (ii) of the Sindh Government Rules of Business, 1986, the Government of Sindh is pleased to notify the "Cabinet Committee on Finance", with the following composition and terms of reference:-

COMPOSITION OF THE COMMITTEE:-

2.	Mr. Saeed Ghani, Minister for Local Government & HTP and Public Health Engineering & Rural Development	Member
3.	Mr. Zia-ul-Hassan, Minister for Home Department and Law, Parliamentary Affairs & Criminal Prosecution Department	Member

TERMS OF REFERENCE OF THE COMMITTEE:-

- The Committee shall be fully authorized to decide the cases in terms of rule 37(ii) of the Sindh Government Rules of Business 1986.
- The Committee may co-opt any other person, including a Government functionary, a technical or professional expert, an academician etc. to assist the Committee in disposal of its business; provided that the member co-opted shall not have right to vote.
- The Committee shall examine and decide upon all cases for supplementary grants on current side and among other things as mentioned in the Budget Manual, Supplementary Grants also include creation of new posts on the non-development side.
- The Committee shall examine and decide upon all fiscal matters such as levy, abolition, remission, alteration or regulation of any tax, fee, etc. incurring of floating loans, raising of debts and issuance of provincial guarantees, on behalf of Provincial Cabinet.
- The Committee shall examine and decide upon cases of provision of supplementary budget grant for new / non-funded development scheme outside ADP.
- The Committee shall examine proposal of a department and decide upon cases for provision of additional funds for ongoing development schemes outside budget.
- The Committee shall also examine proposal of departments and decide upon cases relating to release of funds allocated in ADP for fast moving / priority scheme in relaxation of approved Release Strategy by the Sindh Cabinet.



- (h) The Finance Department & P&D Board shall provide necessary assistance wherever required.
- (i) The GA Wing of SGA&C Department will provide Secretariat support to the committee.

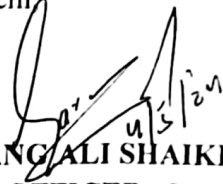
