**3- Eligibility / Conditions:-**

- i) Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
- ii) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- iii) List of machinery and equipment available with documentary proof of its ownership.
- iv) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- v) Undertaking on stamp paper that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- vi) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- vii) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- viii) Certificate of bank showing credit worthiness along with current bank statement.
- ix) The bidder should have experience of such works and should have completed at least 2 similar works (List to be provided with bid).
- x) The bidder should be well versed with the site conditions and should have completed at least 2 No's works under similar conditions (List to be provided with bid).
- xi) The list of Engineers/ staffs employed/ to be deputed at sites should be furnished with documentary proof of payments of their salaries.
- xii) Due to the fact that the fiscal year is near to end and as such re-invitation of tenders are very difficult hence:-
  - a) Pay Orders of 2<sup>nd</sup> lowest & 3<sup>rd</sup> lowest will be retained until the start of work --- (List to be provided).
