- ii) Copy of valid Enlistment letter of Pakistan Engineering Council required for Serial No.2, 3 & 5.
- iii) For electrical work valid license issued from Inspectorate of Electrical License Sindh of the similar region with respect to works, shown above.
- iv) Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
- v) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- vi) List of machinery and equipment available with documentary proof of its ownership.
- vii) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- viii) Undertaking on stamp paper that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- ix) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- x) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- xi) Certificate of bank showing credit worthiness along with current bank statement.
- xii) The bidder should have experience of such works and should have completed at least 2 similar works (List to be provided with the bid).
- xiii) The bidder should be well versed with the site conditions and should have completed at least 2 Nos. works under similar conditions (List to be provided with bid)
- xiv) The list of Engineers / staffs employed / to be deputed at sites should be furnished with documentary proof of payments of their salaries.
- xv) Due to the fact that the fiscal year is near to end and as such re-invitation of tenders are very difficult hence:-  
a) Pay orders of 2<sup>nd</sup> lowest & 3<sup>rd</sup> lowest will be retained until the start of works (List to be provided).
- xvi) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- xvii) Affidavits to the effect that all documents / particulars / information furnished are true and correct.
- xviii) Conditional Tenders will not be entertained.
