- i) For electrical work valid license issued from Inspectorate of Electrical License Sindh of the similar region with respect to works, shown above.
- ii) Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
- iii) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- iv) List of machinery and equipment available with documentary proof of its ownership.
- v) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- vi) Undertaking on stamp paper that firm is not involved in any litigation, Departmental rift, abandoned or unnecessary delay in completion of any work in the Government Departments.
- vii) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- viii) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
- ix) Certificate of bank showing credit worthiness along with current bank statement.
- x) The bidder should have experience of such works and should have completed at least 2 similar works (List to be provided with bid).
- xi) The bidder should be well versed with the site conditions and should have completed at least 2 No's works under similar conditions (List to be provided with bid).
- xii) The list of Engineers/ staffs employed/ to be deputed at sites should be furnished with documentary proof of payments of their salaries.
- xiii) Due to the fact that the fiscal year is near to end and as such re-invitation of tenders are very difficult hence:-
 - a) Pay Orders of 2nd lowest & 3rd lowest will be retained until the start of work --- (List to be provided).
- xiv) Affidavit to the effect that firm has not been black listed previously by any executing agency.
- xv) Affidavits to the effect that all documents / particulars / information furnished are true and correct.
- xvi) Conditional Tenders will not be entertained.

- xviii) Undertaking on stamp paper that firm is not involved in any kind of litigation, departmental rift, abandoned or unnecessary delay in completion of any work in the Government and as well as in private organizations.
