### INSTRUCTIONS:

1. Single Stage - Two envelope Procedure will be adopted for the tender process. Bid shall comprise of a single package containing two separate envelopes. Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
2. Interested Manufactures/Suppliers may obtain the tender document for the supply of above equipments/items from the office of the AIGP (Logistics), 2<sup>nd</sup> floor Central Police Office, I.I. Chundrigar Road, Karachi by submitting an application on their letter head alongwith tender fees from 13-03-2015 to 30-03-2015.

3. Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/c in favour of AIGP Logistics Sindh) should be dropped in the tender box kept in office of AIGP (Logistics), 2<sup>nd</sup> floor Central Police Office, I.I. Chundrigar Road, Karachi on "31-03-2015 at 1400 hours".
4. The tender shall be opened on "31-03-2015 at 1430" hours in presence of Purchase Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room of Central Police Office, Sindh, Ground Floor, I.I.Chundrigar Road, Karachi.
5. Only Manufactures/Suppliers registered with Income Tax and Sales Tax department are eligible to participate in the tenders (Documentary proof required).
6. Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.
7. Conditional tender / application will not be entertained.
8. Competent authority can cancel the bidding process at any time prior to the acceptance of a proposal as per provision of Rule-25(1) of SPPRA Rules.2010.
