4. The bids must be submitted on the above date by 11:00 a.m. in Board Room of the Administration Block of Civil Hospital Karachi situated on second floor.
5. These bids will be opened publicly at 11:30 a.m. on the same day in the presence of bidders or their authorized representatives who choose to attend on the place of submission.
6. Technical and Financial proposals should be submitted in separate envelopes and both should be sealed in third envelope.
7. All quotations shall include Government Taxes etc. (if applicable).
8. The deductions in the bills will be done as per government rules.
9. Bid Security @ 2% of total value of the quoted items by firms in shape of Pay Order / Demand Draft must be attached with "Financial Bid" in favour of the Project Director Shaheed Mohtarma Benazir Bhutto Accident, Emergency & Trauma Centre and Ancillary Services Complex at Civil Hospital Karachi.
10. A photocopy of the Bid Security in shape of Pay Order / Demand Draft without showing the amount figure must be submitted with Technical Bid, failing which bid will be ignored.
